### What are cookies and other tracking technologies?

A cookie is a small text file that can be stored on your device and accessed from there to the extent you agree when you visit one of our sites. The other tracking technologies work similarly to cookies and place small files on your devices or monitor your web site activity to enable us to collect information about how you use our site. This enables our site to recognise your device as opposed to other users of the site. The information below about cookies also applies to these other tracking technologies.

### What types of cookies do we use?

- *Necessary cookies*: these cookies are necessary for us to provide you with the basic features of our website and cannot be turned off in our systems.
- *Non-essential cookies*:
  - Performance and analytics cookies: these cookies allow us to track visits and traffic sources to measure and improve the performance of our website.
  - Functional cookies: These cookies are used to improve functionality and personalisation during your visit.

  - Google Analytics sets this cookie to store and count page views.

  - The \_ga cookie, installed by Google Analytics, calculates visitor, session and campaign data and also keeps track of site usage for the site's analytics report. The cookie stores information anonymously and assigns a randomly generated number to recognize unique visitors.

### What is Google Analytics?

Google Analytics is a web analytics service offered by [Google LLC](#) that tracks and reports website traffic. When Google Analytics is used, interactions of website visitors are primarily recorded and systematically evaluated with the help of analytical cookies. The following data is processed through the use of Google Analytics:

- 3 bytes of the IP address of the called system of the website visitor (anonymized IP address),
- the website called up,
- the website from which the user reached the accessed page of my website (referrer),
- the subpages accessed from the website,
- the time spent on the website
- the frequency with which the website is accessed.

Google states that it will not associate your IP address with any other data held by Google. You can prevent the storage of cookies by setting your browser accordingly. You can also prevent the collection of the data generated by Google as well as the processing of this data by Google by downloading and installing the browser plugin available under the following link: <http://tools.google.com/dlpage/gaoptout?hl=en>.

### What is Facebook Remarketing?

We use so-called "Facebook pixels" of the social network Facebook, which is operated by [Meta Websites Inc.](#) With the help of the Facebook pixels, it is possible for Facebook to determine the visitors of our website as a target group for the display of advertisements, so-called "Facebook ads".

You can object to the collection by the Facebook pixels and use of your data for the display of Facebook ads. You can accept or reject them or view this Cookie Policy before giving your consent to cookies or rejecting them. This allows you to make an informed decision about the cookies we use. You are free to accept or reject cookies but note that browsing our website may be less user-friendly and relevant content may be affected after you reject them.

Regardless of your initial decision, you may from time to time withdraw your consent or adjust your preferences through browser control settings, clearing your cookie folder, or by changing your preferences in our Pop-Up Consent Tool.
